#### I AGREE THAT I / WE

- will register all kittens bred by me;
- will microchip all kittens and cats owned or bred by me as this is Qld law;
- will provide the kitten / cats registration & pedigree to all purchaser's of kittens / adult cats etc;
- will provide vaccination cards as well as diet and care documents to new owners;
- will transfer all kittens and cats into the new owner's names when I sell them as this is the breeder's responsibility, not the new owner;
- will desex all kittens bred by me that are not intended for registered breeders, therefore that means all pet kittens must be desexed before leaving my cattery and I will send the desexing certificates to the Registrar with all Litter Registration Applications;
- will check all details of any registered breeders that I might sell an entire kitten to and understand they need to be affiliated with a registering body that is affiliated with CCC of A, ACF or ANCATS in Australia. This can be checked by contacting the CQI Registrar. Also, I understand that these breeders need to provide to me, their body of affiliation, their breeder number and prefix;
- will not let kittens leave my premises until at least 12 weeks of age. [2021]
